Minutes

<u>Call to Order</u>: Meeting called to order by Rick Wood at 6:04 p.m.

<u>Establish Quorum</u>: Members present: Rick Wood, Nico Snyder; Sandra Van Scotter; Adeyinka Glover. Members absent: Kelly-Kulzer-Reyes; Virginia Gantong; Abigail Teasdale.

Additional Items Added to the Agenda: Spanish interpretation of LVAC meetings.

<u>Public Comment</u>: None (Note: public and other comment at end of meeting. See below.)

Approval of Minutes of 09-2023 Meeting: Carried over to November 6, 2023 meeting.

Status of SDP (Wood):

Report on September SSDAC meeting, including unprofessional conduct policy for SCDD appointees to LVACs; disparities project; best practices project. Rick committed to bring 1 best practice back to the committee next meeting. Sandra asked, "What to other states do?" This is in response to best practices and expenditure of federal SDP implementation funds. December SSDAC meeting the week of 12-11 will be a FMS Town Hall format. SSDAC requested more SDP enrollment data from DDS. Discussion of reporting tool, which is a questionnaire developed by SSDAC to LVAC chairs re: implementation statistics and barriers.

DDS SDP Workgroup: Next meeting 11-02-23. Focus on addressing issues in breakout groups format.

Spanish Interpretation: Director Gates committed to funding interpretation.

KRC Updates:

Enrollment: added 4 participants in last month; continued Hispanic/Spanish language outreach; Melanie Waters reminded committee of upcoming implementation funds discussion.

Discussed KRC Facebook Link Tree—request that it go onto the KRC webpage. Christina Rockwell requested that she become a member of the DDS SDP Workgroup. Monthly IF support group.
