KERN REGIONAL CENTER SELF-DETERMINATION ADVISORY COMMITTEE MEETING MINUTES

November 4, 2024

- 1. Meeting called to order by Sandra Van Scotter at 5:04 p.m.
- 2. Quorum Established. Present were Sandra Van Scotter, Rick Wood, Erica Clark, Norma Tuiasosopo and Lorie Stewart.
 - 3. Additional Items: Sandra explained the SSDAC and KRC LVAC acronyms.
 - 4. Public Comment. None.
- 5. Approval of Minutes. September 9, 2024: Jeff Ibes's last name (Ibes) was added to a blank in the draft minutes. Community Integration Specialists 'name was corrected, as it was misspelled in the draft minutes. Upon Motion by Rick and seconded by Norma, the minutes, as amended/corrected, were passed by acclamation. October 7, 2024: in section 6.c, "grand" was changed to "grant" and "Judge" was changed to "Judy." Melanie Waters advised that her report on implementation funding expenditures was from the grantees 'reports. Upon motion by Lorie and seconded by Norma, the minutes, as amended/corrected, were approved by the vote of all members except for Rick, who abstained.

6. Status of SDP.

Updates: Sandra announced that DDS added updates to its Ombudsperson page on its website, which include new tabs and a more user-friendly format; there are now 21 FMS's on DDS's SDP webpage.

- a. Celebrations. Enrique Roman announced that Ally will host the first in-person orientations in English and Spanish on November 6 at KRC Malibu Room. Rick reported his recent experience with problem-solving conference with GT Independence was positive. More details at the next meeting; the Bishop office of KRC will hold an open house on November 6 from 1-4 pm. Sandra announced the reformation of the KRC client advisory committee which will hold an open house at KRC on November 7.
- b. Obstacles. Rick reported that GT Independence described the SDP in CA as more complicated than in the 16 other states in which it serves as FMS. Sandra described unintended consequences of sole employer legal requirements, such as business license requirements.
- c. Directives. None since 07-24 but other directives impact SDP: implicit bias training, or how we come to see things, interpret what we see based on our cultural experience.

Shannon Lueck presentation. KRC is one of the first RCs to schedule and complete implicit bias training including first Course 4 program in February 2024. Equity presents other courses (7 total) through LMS. Program will repeat in early 2025. KRC also does cultural competency training. Both of these trainings plus person-centered thinking fit into IPP trainings. Sandra reported that vendor rates are posted on the DDS website, as well as DDS provider directory, rate reform, source codes. Enrique reported that rate reform impacts RC providers—will need clarification; reform brings up rates but does not look forward to the future.

- d. Rick reported that there will be a SSDAC Town Hall on December 4 for public to comment; SSDAC now has dedicated full-time staff; summary of best practices efforts by SSDAC which will continue to be posted on its website at SCDD.
- 7. KRC Updates. Copies of surveys re: implementation funds expenditures/reports from Melanie Waters attached (Attachment A).

Shannon Leek, KRC training and information manager, presented changes to the KRC website, including a more prominent place for the SDP. The learning portal allows participants/users to attend SDP courses and receive certificates and displays agendas, minutes, upcoming events. Enrique presented staffing updates, including that recruitment for a director of client services and SDP program manager; an update of enrollment numbers will be provided at the December, 2024 meeting; a great presentation on KRC demographics re: ethnicity, language, caregiver language was made, showing a rich, diverse population (Attachment B); he will present an update on outreach efforts at the December meeting; beginning January, 2025, a new signature page on each participant's IPP will be included acknowledgement of a SDP discussion and option to enroll. By the end of 2025 all participants will have been exposed to the SDP.

Tomas Cubias reported that the SDP video is on hold due to DDS developing language re: the use of AI language to inform the public.

Proposed dates for 2025 LVAC meetings were approved as set forth in the agenda.

- 8. Next Meeting: December 2, 2024. Topics to include the standard topics each month. Melanie reminded the committee of year-5 implementation funding, to be initially discussed at the January 6, 2025 meeting.

Currently there are 11,856 clients at Kern Regional Center with a case management Status 2 designation.


This total does not include the 200 clients currently enrolled in the Self-Determination program.


Ridgecrest: Caretaker Language









Tehachapi: Client Language






Tehachapi: Caretaker Language









California City: Client Language






California City: Caretaker Language












Mojave: Client Language






Mojave: Caretaker Language











Bishop: Caretaker Language







Mammoth Lakes: Ethnicity







Mammoth Lakes: Client Language
