KRC SDP Local Advisory Committee Minutes of Meeting

April 7, 2025

- 1. Call to Order: 5:08 p.m.
- 2. Establishment of Quorum: Present were Sandra Van Scotter, Rick Wood, Erica Clark, Norma Tuaisosopo and Lorie Stewart. A quorum was established.
- 3. Additional Items: None.
- 4. Public Comment: Christiana Moralls announced a new SDP Community lunch meeting the 3rd Tuesday of each month. Rosie Lasca announced handouts available for independent facilitator training academy, SDP workgroup, and more. . . .
- 5. Approval of Minutes of February 3, 2025 meeting: approved by acclamation. Minutes of the meeting of March 10, 2025: Sandra and Norma approved. All other members abstained.
- 6. Status of SDP:
- a, b. Celebrations/Obstacles: Rick presented to a group of Spanish speaking parents of SDP participants in Mammoth Lakes at the invitation of First Choice Solutions. The subjects were conservatorships, powers of attorney and supported decision making. One takeaway was a fear that applying for federal and state benefits would jeopardize a parent's immigration status. Rick suggested that we establish a list of persons who can answer questions from parents (perhaps Erica, OCRA?). Lorie asked is KRC has a policy related to jeopardizing immigration status. Enrique: immigration status is confidential and is not disclosed. KRC will issue a statement confirming this. Christina Rockwell (IF) agrees.
- c. Directives: Sandra spoke to recent DDS SDP Directives: 7n new, but not SDP specific., including transition evaluation from Early Start at age 3; a 9-month wait for the KRC psychologist to complete an evaluation/assessment for services, or less time if there is a private evaluation/assessment paid for by private insurance.
- d. SSDAC Updates: Rick announced the next SSDAC meeting to be held the week of June 24 will be an in-person meeting in Southern California. Announcement to come.
 - 7. KRC Updates.
- a-c. Presentation by Katie Hornberger and Cynthia Salomon-Ponce on behalf of Marlene Morales from the SDP Ombudsman office on what they do, types of questions, data re: contacts, etc. Similar to presentations to SSDAC. The PowerPoint will be attached to these minutes. Kayley Proenza asked what the response time is to questions. Goal is 2 business days.

Julio Romero, SDP Program Manager, presented enrollment data (Attachment A).

d. 257 total participants, including 16 new enrollees in 1 month. Reasons for increase include collaboration with IFs, staff; and troubleshooting meetings with IFs.

e. Melanie Waters presented the draft RFP re: SDP implementation funds. On motion by Rick and second by Sandra, the committee agreed by acclamation to change the terms to permit proposals to be submitted by 04-28-25, which will be reviewed at the May 5 meeting.

The next consumer advisory committee meeting is to be held on April 17, 2025.

Isis Rasmussen reported that the KRC annual community vendor fair is scheduled for April 16, 2025.
