- 3. DDS will be developing Service Coordinator training with a focus on: Where do committee members fall into these training courses and training for program managers.

7. KRC Updates

- A. Self-Determination Program Enrollment.
 - a. As of September 2025, KRC has 308 enrolled in SDP. Additionally, 180 individuals have completed the SDP Learning Management System
 (LMS) Orientation: with 436 enrolled in English, 107 enrolled in Spanish, nine in ASL, and one enrolled in Korean.
 - b. A conversation regarding other regional centers of similar size to Kern
 Regional Center and data to be collected from SDP, to streamline the SDP enrollment process.
- B. General Updates on the Self-Determination Program.
 - a. No general updates.
- C. Monthly report on the awardees of the SDP Implementation Funding.
 - a. Ally's Comprehensive Services: According to the September 2025 report, they are currently coaching 14 individuals. Participated at a special needs community resources fair on September 27, 2025. Will be participating on the Buddy Walk on October 11, 2025. Along with the million dreams walk

- on October 25, 2025. Ally and Community Integration Specialist worked together on a flyer to be shared at outreach events.
- b. Community Integration Specialist: Currently coaching 12 clients. Are finishing up their transition on our currently Spanish speaking clients with three more on the waiting list. Participated in the Hearts Connection one day conference in Bishop on September 18, 2025, where they held a Q&A session on SDP. They are currently working with over 10 vendors.
- c. RISE Services: No invoices were submitted for this reporting period.
 However, two employees have recently been hired to support program implementation.
- d. Individuals interested in these services can have a conversation with their Service Coordinator.
